Variation of Condition 2 (Approved Plans) of planning permission ref: 2015/6955/P dated 01/11/2017 (as amended by approvals refs 2020/1368/P dated 14/04/2020, 2021/1918/P dated 07/07/2021, 2021/1056/P dated 30/03/2022 and 2022/1796/P dated 25/10/2022) (for: Redevelopment of the site to provide a 7 storey (plus plant and basement) buildings at Panther House and Brain Yard for predominantly employment uses and a new 7 storey plus plant and basement building at 156-164 Gray's Inn Road to provide flexible retail/restaurant uses with 15 self-contained residential units at the upper levels), namely to include: facade alterations, widening of bridge link, reduction in passageway width and height, and rationalisation of brick piers and window panels.

Reason: For the avoidance of doubt and in the interest of proper planning.

- 3 Detailed drawings, or samples of materials as appropriate, in respect of the following, shall, unless otherwise indicated below as already having been discharged, be submitted to and approved in writing by the local planning authority before the relevant part of the work is begun:
- a) Details including sections at 1:10 of all windows (including jambs, head and sill), ventilation grilles, external doors and gates;
  - b) Plan, elevation and section drawings, including fascia, cornice, pilasters and glazing panels of the new shopfronts at a scale of 1:10;
  - c) Manufacturer's specification details of all facing materials (to be submitted to the Local Planning Authority) and samples of those materials (to be provided on site);
  - d) Method plan and details of the cobbles within Brain Yard being retained and reused (as approved under ref 2021/1299/P dated 28/06/2021 or other such details submitted);
  - e) Details for reuse of metalwork inside Brain Yard building;
  - f) Details for reuse and rebuilding of west wall of Brain Yard building including wall, details and thresholds.

The relevant part of the works shall be carried out in accordance with the details thus approved and all approved samples shall be retained on site during the course of the works. All other new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the Camden Local Plan 2017.

- 4 No lights, meter boxes, flues, vents or pipes, and no telecommunications equipment, alarm boxes, television aerials, satellite dishes or rooftop 'mansafe' rails shall be fixed or installed on the external face of the buildings, without the prior approval in writing of the local planning authority.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the Camden Local Plan 2017.

- 5 Prior to the occupation of the development, full details of screening, obscure glazing and other measures to reduce instances of overlooking and loss of privacy to neighbouring occupiers (including screening of the residential and commercial terraces/balconies and obscure glazing of the commercial extensions above Brain Yard and Panther House) shall be submitted to and approved in writing by the Local Planning Authority. The development shall be carried out in accordance with the details thereby approved and permanently

maintained thereafter.

Reason: In order to prevent unreasonable overlooking of neighbouring premises in accordance with the requirements of policy A1 of the Camden Local Plan 2017.

- 6 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the trees in accordance with the requirements of policies D1 and D2 of the Camden Local Plan 2017.

- 7 Prior to the commencement of the above ground superstructure works, full details of hard and soft landscaping and means of enclosure of all un-built, open areas (including terraces, balconies, green roofs, the open courtyard and the pedestrian route through) shall be submitted to and approved by the local planning authority in writing. Details shall include a phased programme of works. The relevant part of the works shall not be carried out otherwise than in accordance with the details and programme thus approved.

Reason: To ensure that the development achieves a high quality of landscaping which contributes to the visual amenity and character of the area in accordance with the requirements of policies D1 and D2 of the Camden Local Plan 2017.

- 8 All hard and soft landscaping works shall be carried out in accordance with the approved landscape details by not later than the end of the planting season following completion of the development or any phase of the development, prior to the occupation for the permitted use of the development or any phase of the development, whichever is the sooner. Any trees or areas of planting which, within a period of 5 years from the completion of the development, die, are removed or become seriously damaged or diseased, shall be replaced as soon as is reasonably possible and, in any case, by not later than the end of the following planting season, with others of similar size and species, unless the local planning authority gives written consent to any variation.

Reason: To ensure that the landscaping is carried out within a reasonable period and to maintain a high quality of visual amenity in the scheme in accordance with the requirements of policies D1 and D2 of the Camden Local Plan 2017.

- 9 The retail/restaurant (A1/A3) uses hereby permitted shall not be carried out outside the following times: 07:00hrs to 23:30hrs Monday to Thursday and 07:00hrs to 00:00hrs Friday and Saturday and 08:00hrs to 23:00hrs on Sundays and Bank Holidays. The commercial use of the open courtyard (as shown in P100 Rev 03) should not be used outside of 08:00hrs to 22:00hrs 7 days a week.

Reason: To safeguard the amenities of the adjoining premises and the area generally in accordance with the requirements of policies A1, A4 and TC1 of the Camden Local Plan 2017.

- 10 Noise levels at a point 1 metre external to sensitive facades shall be at least 10dB(A) less than the existing background measurement (LA90), expressed in dB(A) when all plant/equipment (or any part of it) is in operation unless the plant/equipment hereby permitted will have a noise that has a distinguishable, discrete continuous note (whine, hiss, screech, hum) and/or if there are distinct impulses (bangs, clicks, clatters, thumps), then the noise levels from that piece of plant/equipment at any sensitive façade shall be at least 10dB(A) below the LA90, expressed in dB(A).

Reason: To safeguard the amenities of the adjoining premises and the area generally in accordance with the requirements of policies A1 and A4 of the Camden Local Plan 2017.

- 11 Prior to the commencement of the above ground superstructure works details of the location, design and method of waste storage and removal including recycled materials, shall be submitted to and approved by the local planning authority in writing. The facility as approved shall be provided prior to the first occupation of any of the new units and permanently retained thereafter.

Reason: To ensure that sufficient provision for the storage and collection of waste has been made in accordance with the requirements of policies A1 and CC5 of the Camden Local Plan 2017.

- 12 Prior to the commencement of the above ground superstructure works, details of secure and covered cycle storage area for 149 spaces (130 long stay and 19 short stay) shall be submitted to and approved by the local planning authority. The approved storage areas shall be provided in their entirety prior to the first occupation of the development, and permanently retained thereafter.

Reason: To ensure the development provides adequate cycle parking facilities in accordance with the requirements of policy T1 of the Camden Local Plan 2017.

- 13 The development hereby approved shall achieve a maximum internal water use of 110 litres/person/day. The dwellings shall not be occupied until the Building Regulation optional requirement has been complied with.

Reason: To ensure the development contributes to minimising the need for further water infrastructure in an area of water stress in accordance with policies CC1, CC2 and CC3 of the Camden Local Plan 2017.

- 14 All Non-Road Mobile Machinery (any mobile machine, item of transportable industrial equipment, or vehicle - with or without bodywork) of net power between 37kW and 560kW used on the site for the entirety of the demolition and phases of the development hereby approved shall be required to meet Stage IIIA of EU Directive 97/68/EC. The site shall be registered on the NRMM register for the demolition and construction phases of the development.

Reason: To safeguard the amenities of the adjoining occupiers, the area generally and contribution of developments to the air quality of the borough in accordance with the requirements of policies CC1, CC2 and CC4 of the

Camden Local Plan 2017.

- 15 All units hereby approved shall be designed and constructed in accordance with Building Regulations Part M4 (2) with at least 10% designed and constructed in accordance with Building Regulations Part M4 (3) adaptable.

Reason: To ensure that the internal layout of the building provides flexibility for the accessibility of future occupiers and their changing needs over time, in accordance with the requirements of policy H6 of the Camden Local Plan 2017.

- 16 Piling shall be completed in accordance with the details as previously approved under ref 2020/1631/P on 27th May 2020 and ref 2021/1299/P on 28th June 2021, or with other such details as submitted to and approved in writing by the Local Planning Authority.

Reason: To safeguard existing below-ground public utility infrastructure and controlled waters in accordance with the requirements of policies CC1, CC2 and CC3 of the Camden Local Plan 2017.

- 17 The approved terraces for the employment uses (B1), as shown on the 2nd floor (P102 Rev 04) and 4th floor (P104 Rev 04), shall not be used outside the hours of 08:00 and 20:00 Monday-Friday.

Reason: In order to prevent unreasonable overlooking of neighbouring premises in accordance with the requirements of policy A1 of the Camden Local Plan 2017.

- 18 All external doorways, except for fire doors or for access to utilities, should not open outwards towards the public highway/footway/courtyard spaces. The proposed doors must either open inwards or have a sliding door so they do not restrict the flow of pedestrians or risk being opened onto those passing by.

Reason: In order to enhance the free flow of pedestrian movement and promote highway safety and amenity in accordance with policies D1 and T1 of the Camden Local Plan 2017.

- 19 Prior to the commencement of the above-ground superstructure works, details of anti-vibration measures shall be submitted to and approved in writing by the Council. The measures shall ensure that the plant/ equipment and extract/ventilation system and ducting are mounted with proprietary anti-vibration isolators and fan motors are vibration-isolated from the casing and adequately silenced. Approved details shall be implemented prior to occupation of the development and thereafter be permanently retained.

Reason: To safeguard the amenities of the adjoining premises and the area generally in accordance with the requirements of policies A1 and A4 of the Camden Local Plan 2017.

- 20 The noise level in rooms at the development hereby approved shall meet the 'Good' noise standard specified in BS8233:1999 for internal rooms and external amenity areas.

Reason: To safeguard the amenities of the future occupants of the development in accordance with the requirements of policies A1 and A4 of the Camden Local Plan 2017.

- 21 Prior to the commencement of the above-ground superstructure works, details of the light-enhancing materials (i.e. white glazed bricks or similar) to be incorporated as part of the development to ensure acceptable daylight levels at 52-54 Mount Pleasant Hostel are achieved have been submitted to and approved in writing by the local Planning Authority. The development shall be carried out in accordance with the details thereby approved and permanently maintained thereafter.

Reason: In order to ensure acceptable levels of daylight are achieved for the adjoining occupiers in accordance with the requirements of policy A1 of the Camden Local Plan 2017.

- 22 The scheme of assessment shall be completed in accordance with the details as previously approved under ref 2020/1631/P on 27th May 2020, or with other such details as submitted to and approved in writing by the Local Planning Authority. The assessment should consist of site reconnaissance, conceptual model, risk assessment and proposed schedule of investigation and be submitted to the Local Planning Authority. The scheme of assessment must be sufficient to assess the scale and nature of potential contamination risks on the site and shall include details of the number of sample points, the sampling methodology and the type and quantity of analyses proposed. The scheme of assessment must be approved by the Local Planning Authority and the documentation submitted must comply with the standards of the Environment Agency's Model Procedures for the Management of Contamination (CLR11).

Reason: To protect future occupiers of the development from the possible presence of ground contamination arising in connection with the previous industrial/storage use of the site in accordance with policy A1 of the Camden Local Plan 2017.

- 23 The Site Investigation shall be completed in accordance with the details as previously approved under ref 2020/1631/P on 27th May 2020, or with other such details as submitted to and approved in writing by the Local Planning Authority. This should be undertaken in accordance with the approved scheme of assessment and the written results provided to the Local Planning Authority for their approval. Laboratory results must be provided as numeric values in a formatted electronic spread sheet. Before development commences a remediation scheme shall be agreed in writing with the Local Planning Authority and the scheme as approved shall be implemented before any part of the development hereby permitted is occupied.

Reason: To protect future occupiers of the development from the possible presence of ground contamination arising in connection with the previous industrial/storage use of the site in accordance with policy A1 of the Camden Local Plan 2017.

- 24 Additional significant contamination discovered during development shall be fully assessed and any necessary modifications made to the remediation

scheme shall be submitted to the local planning authority for written approval. Before any part of the development hereby permitted is occupied the developer shall provide written confirmation that all works were completed in accordance with the revised remediation scheme.

Reasons: To protect future occupiers of the development from the possible presence of ground contamination arising in connection with the previous industrial/storage use of the site in accordance with policy A1 of the Camden Local Plan 2017.

- 25 The intrusive pre-demolition and refurbishment asbestos survey shall be completed in accordance with the details as previously approved under ref 2021/1299/P on 28th June 2021, or with other such details as submitted to and approved in writing by the Local Planning Authority. The scheme must be written by a suitably qualified person and shall be submitted to the local planning authority and approved prior to commencement of the development. The scheme as submitted shall demonstrably identify potential sources of asbestos contamination and detail removal or mitigation appropriate for the proposed end use. Detailed working methods are not required but the scheme of mitigation shall be independently verified to the satisfaction of the local planning authority prior to occupation.

Reasons: To protect future occupiers of the development from the possible presence of ground contamination arising in connection with the previous industrial/storage use of the site in accordance with policy A1 of the Camden Local Plan 2017.

- 26 The Stage 1 written scheme of investigation shall be completed in accordance with the details as previously approved under ref 2020/1631/P on 27th May 2020, or with other such details as submitted to and approved in writing by the Local Planning Authority. For land that is included within the WSI, no demolition or development shall take place other than in accordance with the agreed WSI, and the programme and methodology of site evaluation and the nomination of a competent person(s) or organisation to undertake the agreed works.

If heritage assets of archaeological interest are identified by stage 1 then for those parts of the site which have archaeological interest a stage 2 WSI shall be submitted to and approved by the local planning authority in writing. For land that is included within the stage 2 WSI, no demolition/development shall take place other than in accordance with the agreed stage 2 WSI which shall include:

- A. The statement of significance and research objectives, the programme and methodology of site investigation and recording and the nomination of a competent person(s) or organisation to undertake the agreed works.
- B. The programme for post-investigation assessment and subsequent analysis, publication & dissemination and deposition of resulting material. This part of the condition shall not be discharged until these elements have been fulfilled in accordance with the programme set out in the stage 2 WSI.

The written scheme of investigation will need to be prepared and implemented



by a suitably professionally accredited heritage practice in accordance with Historic England's Guidelines for Archaeological Projects in Greater London.

Reason: In order to ensure the identification of and minimise damage to important archaeological remains which may exist on this site, in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

- 27 The approved gates on the 156-164 Gray's Inn Road building shall remain open between 06:00 and 00:00 7 days a week.

Reason: To allow freedom of pedestrian movement and activity while ensuring the safety and amenity of residents is protected in accordance with policy A1 of the Camden Local Plan 2017.

- 28 Mechanical Ventilation details shall be completed in accordance with the details as previously approved under ref 2022/4269/P on 31/01/2023, or with other such details as submitted to and approved in writing by the Local Planning Authority.

Reason: To safeguard the amenities of the adjoining premises and the area generally in accordance with the requirements of policies TC1, A1 and A4 of the Camden Local Plan 2017.

- 29 NO2 System Intake details shall be completed in accordance with the details as previously approved under ref 2022/4269/P on 31/01/2023, or with other such details as submitted to and approved in writing by the Local Planning Authority.

Reason: To safeguard the amenities of the prospective occupiers, adjoining premises and the area generally in accordance with the requirements of policies A1, CC1, CC2 and CC3 of the Camden Local Plan 2017.

- 30 Full details in respect of the brown/green roof in the area indicated on the approved roof plan, designed to support both black redstarts and invertebrates and to increase bat foraging on the site, shall be submitted to and approved by the local planning authority before the relevant part of the development commences. The details shall include species, planting density, substrate and a section at scale 1:20 showing adequate depth is available in terms of the construction and long term viability of the green roof, and a programme for a scheme of maintenance shall be submitted to and approved in writing by the local planning authority. The brown/green roof shall be fully provided in accordance with the approved details prior to first occupation and thereafter retained and maintained in accordance with the approved scheme of maintenance.

Reason: In order to ensure the development undertakes reasonable measures to take account of biodiversity and the water environment in accordance with policies CC1, CC2 and CC3 of the Camden Local Plan 2017.

- 31 Prior to first occupation of the development, a plan showing details of bird and bat box locations and types and indication of species to be accommodated shall be submitted to and approved in writing by the local planning authority.

The boxes shall be installed in accordance with the approved plans prior to the occupation of the development and thereafter retained.

Reason: In order to secure appropriate features to conserve and enhance wildlife habitats and biodiversity measures within the development, in accordance with the requirements of policies CC1, CC2 and CC3 of the Camden Local Plan 2017.

- 32 Prior to the commencement of the above-ground superstructure works, detailed plans showing the location and extent of photovoltaic cells to be installed on the building shall have been submitted to and approved by the Local Planning Authority in writing. The measures shall include the installation of a meter to monitor the energy output from the approved renewable energy systems. The cells shall be installed in full accordance with the details approved by the Local Planning Authority and permanently retained and maintained thereafter.

Reason: To ensure the development provides adequate on-site renewable energy facilities in accordance with the requirements of policies CC1 and CC2 of the Camden Local Plan 2017.

- 33 The sustainable drainage system as approved (Flood Risk Assessment And Surface Water Drainage Statement, Robert West, November 2015) shall be installed as part of the development to achieve a minimum 50% reduction in run off rate/greenfield run off rates. The system shall include green and brown roofs and a minimum of 36m<sup>3</sup> below ground attenuation, as stated in the approved drawings and shall thereafter retained and maintained in accordance with the approved maintenance plan.

Reason: To reduce the rate of surface water run-off from the buildings and limit the impact on the storm-water drainage system in accordance with policies CC1, CC2 and CC3 of the Camden Local Plan 2017.

- 34 Prior to occupation, evidence that the system has been implemented in accordance with the approved details (Flood Risk Assessment And Surface Water Drainage Statement, Robert West, November 2015) as part of the development shall be submitted to the Local Planning Authority and approved in writing. The systems shall thereafter be retained and maintained in accordance with the approved maintenance plan.

Reason: To reduce the rate of surface water run-off from the buildings and limit the impact on the storm-water drainage system in accordance with policies CC1, CC2 and CC3 of the Camden Local Plan 2017.

- 35 Notwithstanding the details shown on drawing no. 14093 A [00] P100 Rev 04 (Proposed Ground Floor Plan), within the Gray's Inn Road frontage no more than one of the frontages at nos.156, 160, 162 and 164 shall be in Class Eb use at any one time.

Reason: To protect against the effect of non-retail development on the shopping provision and character of the Central London Area as well as the cumulative impact of food, drink and entertainment uses, in accordance with policies A1 and A4 of the Camden Local Plan 2017.

- 36 Prior to the first occupation of the building, an opaque film or covering shall be applied to the glazed elements of the roof extension above Panther House. The implemented film or covering shall be retained permanently thereafter.

Reason: In order to reduce light spillage from the proposed extension into neighbouring premises and to protect those residential amenities in accordance with the requirements of policies D1, D2 and A1 of the Camden Local Plan 2017.

Informative(s):

1 Reasons for granting permission-

This application includes minor-material amendments to a planning permission ref: 2015/6955/P dated 01/11/2017 (as amended).

Overall the works are considered to be minor and acceptable in the context of the original approval. They do not alter the approved scheme in terms of the overall number of residential units provided, the mix and quantum of commercial uses or the overall height of the approved buildings.

The proposed changes include:

- facade alterations,
- widening of bridge link,
- reduction in passageway width and height,
- rationalisation of brick piers and window panels.

Design and conservation

The alteration of the front façade involves brick piers and lintels moved forward, string courses lowered, window panel alterations and Juliet balconies. Overall the changes are minor and do not significantly alter the character of the scheme and therefore area. The building heights and floor levels will be maintained so the appearance will only change slightly but will be read as the same design.

With the changes in width of the passage and bridge link, again, these are small changes in the context of the scheme. These elements will continue to serve the site as before and function in the same way, even with the small reduction in width. The introduction of artwork is positive and considered to sufficiently offset any adverse impacts of the narrowed width.

There are also very minor details including wall buildups and brickwork details that will change on the site. This is considered acceptable and does not impact upon the character of the building or area.

Overall the changes proposed are considered not to result in further harm to the character and appearance of the host building, streetscape and conservation area.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

## 2 Transport

On comparing the consented and proposed layouts, the main doors on the office entrance and the affordable office entrance are larger and reach out further in the proposed layout than they do in the consented layout. This is mitigated by the fact that one of the door assemblies has been shifted into the building slightly. The net restriction to the through route remains unchanged.

The outward opening doors are not ideal but, given the previous approval, the proposals do not raise any significant issues from a transport point of view.

### Residential amenity

The approved buildings would not be changing in size significantly and there would be no new windows that would materially overlook surrounding 13 occupiers. To the front (Gray's Inn Road building) the arrangement is very similar and so the impact is minimised. Therefore there will be no harm to privacy, outlook, light or noise.

### Quality of Accommodation

The layout of the units is staying relatively similar and, with the reduction in glass on the employment building, any issues of overlooking for the occupiers is reduced.

There are also internal alterations, including incorporating the 'link' bridge into the GIA of Apartment 1 in order to increase its floorspace. The changes to the overall party walls allow minimum space standards to be retained in the affordable unit.

No objections have been received prior to making this decision. The planning history of the site has been taken into account when coming to this decision.

As such, the proposed amendments are in general accordance with policies A1, A4, D1, D2, T1, T2, T3, T4 and DM1 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2021 and the National Planning Policy Framework 2021.

Both CIL's will be collected by Camden after the scheme has started and could be subject to surcharges for failure to assume liability or submit a commencement notice PRIOR to commencement and/or for late payment. We will issue a formal liability notice once the liable party has been established. CIL payments will also be subject to indexation in line with the construction costs index.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these

hours.

- 10 You are advised that condition 09 means that no customers shall be on the premises and no noise-generating activities associated with the use, including preparation and clearing up, shall be carried out otherwise than within the permitted time.
- 11 Your attention is drawn to the fact that there is a separate legal agreement with the Council which relates to the development for which this permission is granted. Information/drawings relating to the discharge of matters covered by the Heads of Terms of the legal agreement should be marked for the attention of the Planning Obligations Officer, Sites Team, Camden Town Hall, Argyle Street, WC1H 8EQ.


In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2021.
