This application is to replace single to double glazing windows of the mid floor flat in order to improve energy efficiency.

All 9 windows will be replaced with double-glazing windows. Seven of them will be replaced like for like. Two of them will have different designs.

The existing case window on the lefthand side of the front elevation has a fixed lower part and openable upper part, which makes it difficult to open and close without using a ladder. The proposed design of this window has a fixed upper part and an openable lower part. This design will be the same as the windows in the same position of the neighbouring houses on this street.

The bathroom case window on the west side elevation has 3 sections. The proposed design will have two sections side by side. This window is almost invisible from any public path.

Concealed trickle vents will be installed to all windows.

All windows will use wood material and white colour.
