These trees are too close to the adjacent properties, especially T1 which is casting considerable shade to both adjacent properties. There are also signs of subsidence on the above property.
T1) Leyland Cypress: Reduce height and width by up to 30% (branch lengths up to 4 metres); retain natural and even flowing canopy outline.
T2) Sycamore adjacent to T1: Reduce overall crown by branch lengths up to 2-2.5 metres.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
