Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
G1-Cypress trees on right- reduce height back to previous pruning points, approximately 2m reduction, prune back front face of hedge over garden by 1m (including Rose but keep horizontal Rose branches). Prune in right hand end an additional 1-2 feet from thinnest section at lowest point. Remove Clematis from Birch tree. Create big gap between Birch and Cypress trees.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
