Reason: The tree is now too large for the very restricted planting location and very small rear garden; the tree has out-grown its location; the tree is causing damage to the landscape structures and boundary fence; the tree is the wrong species for its location

  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - $\circ\;$  adding other relevant features on the site (e.g. greenhouse, paths)
