Proposed Work:

FRONT GARDEN: 1 x Tulip (T1) - Reduce crown to previous pruning points, approx. 1.5m reduction.

- 1 x Hornbeam Hedge (T2) Trim side overhanging #6 and top of hedge and cut rose growing in end of hedge on the building back to the boundary.
- 1 x Damson (T3) Reduce crown by approximately 1m.
- 1 x Lime (T5) Remove epicormic shoots through front fence.

REAR GARDEN: 1 x Laurel (T6) - Reduce height by approx. 1m and reduce branches away from building by approx. 0.5m.

- 1 x Willow (T8) Reduce height by approx. 2m and lift crown away from bamboo & shrubs by approx. 1m.
- 1 x Privet (T9) Reduce crown by approx. 1m.
- 1 x Apple (T11) Lift crown away from roof by 1.5m and thin crown by approx. 20%
- 1 x Cabbage Palm (T12) Fell to ground level.

The Council has considered your notification of intended works to trees dated 28 November 2023 and does not wish to object.
