Proposal:

Installation of metal balustrade on second floor flat roof for the provision of a roof terrace. Replacement of rear window with timber patio doors.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 The development hereby permitted shall be carried out in accordance with the following approved plans:

10DC-PL-00, 10DC-PL-01, 10DC-PL-02, 10DC-PL-03, 10DC-PL-04, 10DC-PL-05, 10DC-PL-06, 10DC-PL-07, 10DC-PL-08, 10DC-PL-09, 10DC-PL-12, Location Plan, Design Access and Heritage Statement

Reason: For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of Policies D1 and D2 of the London Borough of Camden Local Plan 2017.

Informative(s):

1 Reasons for granting permission:

The proposed roof terrace covers the entirety of the flat roof at the rear of the building and would be enclosed by a raised brick parapet of 0.35m in height, and a metal balustrade of 0.5m in height. Although the alterations would be visible from the public realm, the use of matching brick and metal balustrades are traditional materials and are considered appropriate for use on the historic host building and wider Conservation Area.

The proposed timber framed external door is acceptable in terms of design, materiality, size and scale. It is not considered to have any detrimental impact on the rear elevation of the building nor wider Conservation Area.

Special regard has been attached to the desirability of preserving or enhancing the Fitzjohns Netherhall Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

Given the location of the roof terrace and the distance to neighbouring occupiers, it is not considered to cause significant harm to neighbouring amenity in terms of overlooking, privacy and noise and any views would be oblique. Roof terraces are already established adjacent to the application site.

No responses were received following statutory consultation. The site's planning history and relevant appeal decisions were taken into account when coming to this decision.

As such, the proposal is in general accordance with Policies A1, D1, and D2 of the Camden Local Plan 2017. The proposed development also accords with the policies of the London Plan 2021 and National Planning Policy Framework 2023.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2023.
