T1: Hawthorn (7m): Pollard to 30% of present height removing 2m of growth to keep tree at a size suitable for its location T2: Hawthorn (6m): Pollard to 30% of present height removing 2m of growth to keep tree at a size suitable for its location T4: Robinia (15m): Fell as too close to neighbouring property to continually prune. Re-growth comes back too quickly and too aggressively. T5: Mulberry (6m): Reduce end weight by 2m as tree is leaning on roof. This will stop the tree leaning further.
