REAR GARDEN: 1 x Goat Willow (T1) - Reduce by approx. 1.5m. Crown thin by 20%.

1 x Indian Bean (T2) - Re-pollard as a basic structure for re-growth.

FRONT GARDEN: 1 x Chinese Privet (T3) - Raise crown by approx. 1m over stairs and pavement.

The Council has considered your notification of intended works to trees dated 12 December 2023 and does not wish to object.

from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
