Lime tree at front of property: Remove to ground level.

This tree has major cavity half way up main stem. The tree has routinely been pollarded to mitigate the risk of failure. At this stage the client would prefer to remove the tree and replace with substantial silver Birch.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
