Proposed Work:

FRONT GARDEN: 1 x Willow (T1) - Reduce height to halfway between previous pollard points and ground level, approx. 3m from ground level.

1 x Plum (T3) - Fell to ground level.

1 x Cercis (T4) - Remove two stems to ground level.

1 x Elaeagnus (T5) - Reduce height to approx. 1.5m from ground level.

1 x Acer (T6) - Remove stem over hive, to wall height.

The Council has considered your notification of intended works to trees dated 05 December 2023 and does not wish to object.

from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
