Oak tree in rear garden: Full crown reduction by up to 3 metre branch lengths; the tree has been reduced before so all cuts will be made within the existing reduction framework; remove all dead and defective wood; all pruning cuts will be made to suitable growth points in line with BS3998 Arboricultural Standards.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
