I would like to object to the planning application for causing a loss of amenity to our house (40 Argyle Square), and having a detrimental effect on the Bloomsbury Conservation Area and the surrounding listed buildings.

The main reason for my objection is due to the loss of light in my daughter's bedroom. The analyses from the Right of Light Surveyors demonstrate this. She is currently at school and works from the desk in her room, the cabins have blocked out much of the precious natural light the room receives.

The cabins have been causing light pollution into the house, causing out-of-hours noise disturbances, loss of residential parking, and block views of the square. I am also concerned with the potential noise from the nearby air conditioning units.

There are numerous inconsistencies between the applicant's proposal to what has been built. We have been disappointed by the lack of consultation, the misleading information given by the applicant, and the lack of attempt to mitigate harm. The cabins are located in a sensitive area, which is not suitable for the proposal.

Additionally, the LPA have a duty to preserve the setting of the listed buildings and the Bloomsbury Conservation Area. I, therefore, hope that the cabins can be moved to an area that does not cause harm.

I am the Director and owner of Kings hotel Ltd at 36-37 Argyle Square WC1H8AL I write to object to the grant of planning permission for the suspension of parking bays and placement of Welfare cabins on the west side of Argyle Square as part of the Belgrove House development on the following basis:-

- 1. I and many of my neighbours were not consulted, even though we are directly affected see original CWP management plan for list of consultees.
- 2. It was only brought to my attention from Friends of Argyle Square whose objections I echo. And as a consequence we have had to incur considerable cost and expense in seeking legal advice, which again the developers have merely side stepped.
- 3. The siting of the welfare cabins proposed cause significant loss of light to my property confirmed by the developers own surveyor as well as loss of amenities such as parking spaces, and has an adversely detrimental effect on the aesthetics of the area which looks like a building site/ red light district with its red neon lights and unmonitored building attracting unsavoury characters at night which is an image that the area has previously successfully got rid of for many years. This has caused increased cost to my business for additional security at night as well as irreparable damage to the areas reputation and hotel business for many of the hoteliers in the area and for which as far as I am aware, has not been considered or any proposals in mitigation offered by the developers who have acted in bad faith and proceeded to erect the cabins at an increased height in spite of their own surveyors report and before even obtaining planning permission.
- 4. The provision of welfare cabins is not necessary as there are many amenities and service providers in the local area who could provide equivalent services at very competitive prices and which would be of benefit to the local community, as opposed to causing an eyesore and obstruction and damage to the local business for several years. I personally introduced Mace to the church manager adjacent to their site who was happy to consider letting their facilities as well as providing an extensive list of nearby serviced offices and accommodation but it was clear that they were only playing lip service to the alternative proposals prioritising the cost and business efficacy for their business regardless of the cost and disruption to neighbourhood and our businesses which are much smaller and upon whom the impact and losses are much larger.
- 5. If welfare cabins are deemed to be necessary, they should not be sited in Argyle Square which is a conservation area as well as a square made up of listed buildings where the local inhabitants are unable to make any changes whatsoever. The buildings are single glazed and the noise therefore causes significant disruption to the hotel guests. The narrowing of the road and parking suspension has meant that as hoteliers we are having to pay extra charges to have our laundry and supplies delivered and have significant difficulty in carrying out simple maintenance work eg washing windows etc because of the lack of parking or places to even stop to load and unload.
- 6. It is very unfair that a large developer should be allowed to bypass the conservation rules and place outbuildings which are clearly not in keeping with the area on one of the last remaining garden squares.

As a local planning authority, I sincerely hope you will not allow these proposals for welfare cabins which are unnecessary to the development, to continue .The development itself will already cause significant disruption and the developers should be taking steps to minimise the disruption not increase it or destroy other local businesses (who pay large amounts in business rates)and neighbourhood in the process
