T1- Large synonym London Plane tree in the rear garden around 40-50m in height & around 25m in diameter. Previous reduction points are visible with 6-8m of growth on each new shoot.

Would recommend taking back to previous points so a re pollard.

When it's in full leaf it block ALL sunlight into the garden and across the rear of the property

T2 - Large Cherry tree in rear garden of neighbouring boundary has around 6-8m of growth covering the area with f the properties garden and when in leaf, stops all sunlight reaching the back of the property.

T3 - Small Cherry tree to the left in rear garden has had a huge amount of ivy grown up and around the tree and has started killing the tree. It has a lean towards the house & exposed roots 6-8 inches above ground. Stem is around 10 inches in diameter.

I would recommend removing this tree to stop any further problems also the garden design will be including new planting plan for wildlife and it's surroundings

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
