T1 - Approx. H15+ S4 16DBH Sorbus Crown reduce height by 2-3m. Reduce laterals by 0.5-1m Thin 10% Remove deadwood

T2 - Approx. H15+ S10+ 38+DBH Fig Crown reduce height and sides by 3-4m. Thin 10% Remove deadwood Lift 4m

T3 - Approx. H12 S12 52DBH - twin stem Fig Crown reduce height and sides by 3-4m. Thin 10% Remove deadwood Lift 4m

T4 - Approx. H17 S12 68DBH twin stem Fig Crown reduce height and sides by 3-4m. Thin 10% Remove deadwood Lift 4m

T5 - Approx. H10 S3 15DBH dead Sorbus Fell

(Leave stump at 2m at tenants request)

T6 - Approx. H17 S7 26DBH Sorbus Crown reduce height by 3-4m Reduce laterals by 2-3m Thin 10% Remove deadwood

T7 - Approx. H8 S3 15DBH Sorbus (in decline) Remove major deadwood only.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
