We previously had permission to remove cedar pine, but due to cost of living crisis we were unable to remove tree. However we would now be able to get a tree surgeon to remove tree from the back garden.

The below still applies.

On closer inspection the garden is suffering as a result of the cedar pine as it's causing significant harm to our lawn and adjacent structures (moss and reduced vegetation)

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
