REAR GARDEN T1 Cherry (Prunus spp) Remove select branches as indicated by garden designer (see photos for guidance). Crown clean remaining tree through removal of

any weak, crossing, dead or damaged branches. Final height unchanged. Final spread = unchanged.

FRONT GARDEN

T2 Magnolia × soulangeana Remove crossing limb growing up from the base of the tree and crown clean through removal of water shoots. Final height

unchanged. Final spread = unchanged.

T3 Cherry (Prunus spp) Carry out a formative prune as part of general maintenance to leave a more healthy tree. Final height unchanged. Final spread = unchanged.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
