T1 - Approx. H15 S10 50DBH Oak (TPO Tree - Tree work is to be undertaken to remove dead branches to improve form and increase safety in accordance with good arboriculture practice and maintain the future wellbeing and growth of the trees.)

Remove regrowth (approx. 3-4m) back to previous pruning points.

T2 - Approx. H13 S3 20+DBH Eucalyptus

Crown reduce height by approx. 4-5m (regrowth). Tidy laterals.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
