Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Cherry - 50% crown reduction in height and 25% all round reduction in canopy spread. retaining a natural domed shape to crown, and leaving the tallest point no more than 6m above ground level. The tree currently has a lateral spread of around 4.5m, and as well as reducing the tree in height, side branches are to be reduced all round by around 50cm from branch tips, keeping branches clear of neighbouring fences. The tree has grown vigorously in a sheltered spot and requires regular cutting back or pruning. This will prevent excessive shading the small garden area at 15 St Augustine's rd. reduce the risk of limbs failing in extreme weather and possibly damaging fences and other adjacent structures such as sheds and greenhouses.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
