Proposal:  
REAR GARDEN: 1 x Lime (ID1) - Thin crown to remove approx. 15% of live branches to reduce crown density. Most thinning cuts will be between 2cm - 3cm in diameter. Reduce regrowth back to previous points by approx. 2m - 3m.

The Council has considered your application dated 02 January 2024 and decided to grant consent subject to the following condition(s):
