Proposed Work:

FRONT GARDEN: 1 x Cherry (T1) - Reduce live branches as needed by 1.5m - 2m length reduction, centre of canopy. Reduce interfering, over-extended branches as needed by 1m - 2m length reduction, entire canopy. Reduce branches growing over neighbour's side back to boundary by 0.5m - 1m keeping shape..

The Council has considered your notification of intended works to trees dated 29 November 2023 and does not wish to object.
