FRONT GARDEN: 1 x Cherry (T1) - Reduce crown to previous points of reduction. Crown lift by 1m - 2m.

1 x Hawthorn (T2) - Reduce crown by up to 2m.

REAR GARDEN: 1 x Pear (T3) - Reduce crown extremities by 2.5m - 3m.

The Council has considered your notification of intended works to trees dated 05 January 2024 and does not wish to object.
