Reason: For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017.

The opening hours of the business, and use of any air handling equipment, shall be limited to the following times: 08:00 hours to 22:00 hours - Monday to Saturday, and 09:00 to 21:00 on Sundays. The doors to the order point shall be securely closed outside these hours.

Reason: To safeguard the amenity of the adjoining premises and the area generally in accordance with policies A1and A4 of the London Borough of Camden Local Plan 2017.

Cooking operations on-site shall be limited only to stewing, baking and heating/boiling, and there shall be no frying, grilling, roasting or other food preparation that primarily involves cooking in hot oils or fats.

Reason: To protect the amenity of local residents from strong fumes and odours, and to protect local school children from the negative health impacts associated with traditional hot takeaway foods, in accordance with Policy A4 of the London Borough of Camden Local Plan 2017 Policy E9 of the London Plan 2021.
