## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Four crack willow trees (*Salix fragilis*) are located at Camden Lock market and were last pollarded in 2017 under application reference 2017/5003/T. Two trees are currently leased to the Ice Warf, JD Weatherspoons pub on the southern side of the lock have asked Canal and River Trust to undertake the works on their behalf. The remaining trees are located on the northern side of the lock, with one directly adjacent to the market and the second tree owned by the trust was located to the north-east. A meeting with an arborist was undertaken on the 1st of February 2024 to agree a scope of works. The accompanying document 'Camden Lock Willows' shows the location of each of the trees on a map with an allocated number.

### Scope of works

T1 - Pollard branches back to previous level remove new growth and uncover the CCTV located to the west of the tree. Remove deadwood and reduce crown height by 25%.

T2 - Pollard branches to back to previous level and to remove new growth impacting the pub. Remove broken limb located near the crown of the tree. Reduce crown height by 25%

T3 - Pollard branches back to previous level and to remove new growth and reduce crown height by 25%

T4 - Pollard branches back to previous level and to remove new growth and reduce crown height by 25%

The works will be undertaken over two days on a weekday morning in order to minimise disturbance for the general public. Starting around 7am using electric tools to reduce noise with work finishing by 12pm. Arrisings will be taken off site using a work boat owned by Canal and River Trust. Iron Footbridge over Regents Canal and the towpath on the southern side will be closed temporarily whilst works are undertaken on T1, T2 and T3. The towpath on the northern side will be temporarily closed during the works on T3 and T4. Trust volunteers and contractor ground staff will manage the general public to ensure they do not enter the works area.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
