Front Garden:

T1: Lime: Approximately 5.00m-6.00m (Growing on Eastern Boundary): Thin crown density by approximately 20%. Reduce crown by up to 1.20m.

Remove dead wood. General maintenance.

- T2: Lime: Approximately 5.00m-6.00m: Re-pollard, Reduce back to previous and most recent pollard points. General maintenance.
- T3: Lime: Approximately 5.00m-6.00m: Re-Pollard, Reduce back to previous and most recent pollard points. General maintenance.

Rear Garden:

T4: Mature Lime: Approximately 17.00m: (Left hand, western boundary): Reduce crown height by up to approximately 2.75m. Reduce lateral and sub lateral branches by up to approximately 1.25m back to previous and most recent reduction points. Thin crown density throughout by 20%. Remove dead wood and broken branches throughout crown. General maintenance.

G1: Group of Mature Limes: Approximately 17.00m: Thin crown density of all trees within the group by approximately 25%. Remove ivy. Reduce crown heights by up to approximately 1.50m whilst retaining naturally undulating height line. Reduce lateral and sub lateral branches by approximately 1.20m. Remove dead wood throughout. General maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

e.g. Oak (T3) - Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - o mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
