Tree refs: T13 – T67 inclusive: 2 x Avenues of early mature – mature Quercus rubra (both sides of central path through garden)

- Sensitively crown lift all low hanging branches of Quercus rubra trees within avenue to a neat and even level of 5m above ground, by pruning of smaller diameter branches only

Tree ref: T57 Early mature London plane within northern section of garden with low crown encroaching onto path below

- Sensitively crown lift to an even height of 3.5m above ground, by pruning of smaller diameter branches only

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)

  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
