This is a II* listed building, and it is so in recognition of the unique architectural and engineering features it displays, including of course its communal heating system. The system was designed as a low key, concrete embedded/radiant wall one, precisely to allow the brutalist features of the building to manifest themselves in all their unique character. The new heating system, and it particular the surface distribution network and radiators being proposed, would irremediably and irreversibly alter that.</p> <p>I am also persuaded that Camden has failed to appreciate the social implications of its proposed works. The majority of residents are council tenants, many of them from a disadvantaged socio-economic background. Radiators and individual controls would have a detrimental impact on them. While s. 1 of the EaA2010 has not been implemented, there is still a PSED for Camden to discharge in respect of a number of other characteristics, including race, that strongly overlap with socio-economic disadvantage. I have seen no evidence that Camden has discharged its PSED and believe that the application should be refused until it does.</p> <p>The application for Listed Building Consent should therefore be unconditionally refused.</p> |
