
I hope this e-mail finds you well. It's a been a while, but rest assured the O2 Finchley Rd project will soon be up and running fully as the new (and hopefully final) planning application has gone in recently and fingers crossed this will get the approved in the next few weeks.

I was actually hoping that you could perhaps help with a query that we have on another project that some of my colleagues are working on.

The site we are looking at is located above the Thames-Lee Tunnel which I believe is a strategic main constructed post WW2 as a drought alleviation measure. We have the below image from the asset search and the site is located between shafts 14 and 15.


Our client has previously been advised a few years ago that the exclusion zones for the Thames-Lee Tunnel should be 10m horizontally and 15m vertically and that any excavation above or adjacent to the tunnel carries a risk of causing catastrophic failure of the tunnel and as such any development within 5m of the outside face of the tunnel must be reviewed by TW.

Do you happen to know anything about this tunnel or the procedure we should go through if we wanted to do any construction works over it? Or if you could point us to the person we should contact within TW to discuss this in more detail that would be much appreciated.

Basically we want to confirm the above noted exclusion zones and whether or not any excavation works above the tunnel are completely prohibited regardless if outside the exclusion zone.
