Thursday, December 14, 2023 14:48 "I'm afraid we don't have the resources to review information in detail and answer lots of questions prior to submission. However, I have taken a quick look at your questions and consider you're correct to respond 'no' where you have. The design & access statement is fine. In terms of the fee, the exemption only applies to works that are directly associated to the disability, for example an access ramp. I'm afraid the application would therefore be eligible.

I would recommend submitting your application and once an officer is assigned, they will be happy to assist with any questions."

Wednesday, November 29, 2023 15:57 "As the window is to a non-original 1980s extension, the double glazing element is likely to be acceptable but I would want a Conservation Officer to advise you once they have an understanding of the property. Provided that everything else remains the same as existing, or as close to it as possible, then I don't see any issue."

Wednesday, November 29, 2023 11:52 "As you live in a listed building, this would require a conservation officer to visit the site to understand the acceptability of the works. In addition to planning permission, it would also need listed building consent which is free of charge. I would recommend submitting the planning application and listed building consent applications via the planning portal and an officer will be in touch in due course."
