T2) Cherry by gate: General crown tidy by removing over-extended lateral growth by up to 1.5 metre branch lengths, remove crossing branches and any dead and defective branchwood.
T3) Magnolia adjacent to T2: Reduce overall crown by up to 1.5 metre branch lengths.
