## DECISION

Town and Country Planning Acts 1990 (as amended) Town and Country Planning (Tree Preservation Order) Regulations 1999 **GRANT CONSENT FOR WORKS TO TREE/S UNDER A TREE PRESERVATION ORDER** 

Address: **Private Communal Gardens** r/o 2 - 10 Wadham Gardens & 44 - 64 Elsworthy Road London NW3

Proposal: IN COMMUNAL GARDENS (SEE REPORT): 1 x Red Oak (T1) - Fell to ground level. 1 x Red Horse Chestnut (T2) - Fell to ground level.

The Council has considered your application dated 18 January 2024 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the

tree(s).

3 Between February 2024 and April 2024, a Red Oak (Quercus rubra) and an Indian Horse Chestnut (Aesculus indica) shall be planted to replace the application trees T1 & T2 respectively, in the communal gardens of the property. The trees shall be nursery grade heavy standards with girth sizes of 12-14cm at 1m above the root collar and no less than 2m from the locations of the application trees and no less than 1m from structures unless otherwise agreed with the council in writing. The trees shall be planted and maintained in accordance with BS8545:2014.

Reason: In order to comply with s.206 of the Town and Council Planning Act 1990 (as amended).

1 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
