Details of the freeholders and leaseholders were originally sought from the building management team for the whole site (including 22 Upper Woburn Place and Endsleigh Court, 24 Upper Woburn Place). The building management team were unable to provide the requested information and provided details of their legal team to contact. Despite a number of requests to the solicitors they have been unable/unwilling to provide all details of the owners of the freehold or tenants within the building. As a results of not being able to identify the owners of site and thus not being able to issue either a certificate A or B notice, a Certificate D notice has been placed in the 'Camden New Journal' - dated 8th February 2024. The public notice will read as follows:
