Proposed Work:

REAR GARDEN: 1 x Sycamore & 2 x Limes (G1) - Crown reduction by approx. 5m in height and reduce boundary overhang to 24 Millfield Lane by up to 3m.

Reduce remaining 3 x Sycamores that overhang the boundary to 24 Millfield Lane and house along the same Northern boundary by up to 3m, matching into previously reduced side of the trees and cutting back laterals by up to 3m to minimise overhang.

The Council has considered your notification of intended works to trees dated 13 December 2023 and does not wish to object.
