T2: Yew: Reduce height by 1.5 metre & Lateral Spread by 1.5 metre. T3: Apple: Remove a limb pushing fence & thin out by 25%. T4: Birch: Reduce height by half metre & crown lift by 1.5 metre. T5: Bay: Crown lift by 2 metre & reduce height by half metre. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
