The extent of the demolition proposed is limited to specific and small areas, many of which are contemporary.

Part of the demolition will require a small section of the modern flat roof to be removed.

The rear elevation will require the removal of several windows - these are modern windows (replacements of the originals dating several decades back).

The proposal is positioned in a location which minimises the alterations to the historic shell by aligning itself over the contemporary roof and existing openings, meaning no new openings are required, just minor alterations to the existing openings, which are modest in scale.
