Explanation for Proposed Demolition Work

Why is it necessary to demolish all or part of the building(s) and/or structure(s)?

A structural survey was carried out in May 2023 and has been included in the planning application. It found that the property is in a dilapidated and uninhabitable condition with dry rot to structural timber, and extensive damp. Asbestos is identified for removal and the presence of services infrastructure is ambiguous. Furthermore the windows, roof and gutters require wholesale replacement. There is also evidence of ground movement resulting in damaged brickwork to the building and the hardstandings.

In light of the the inherent deficiencies described in terms of environmental impact, quality of internal environment and limited elements of the original building which might be salvageable, the report recommends that the building is best considered beyond its useful service life and is now best wholly demolished and replaced with a new structure in its entirety.
