- 1 x Brambly Apple (T2) Reduce height by 3m 3.5m Reduce crown spread to balance and shape (approx. 2m 2.5m) Thin throughout the crown by 20%.
- 1 x Hawthorn(T3) Reduce height to 5m Reduce remaining spread to shape (approx. 2m).
- 1 x Magnolia (T4) Reduce height by 1.2m 1.5m above previous reduction points. Reduce crown spread to balance and shape (approx. 0.5m 0.8m). Thin throughout the crown by 15%. Remove old pruning stubs.
