The subject property is a previously converted mix used development comprised of 11 flats split over three upper floors and a ground floor commercial unit. The property is formed in cavity wall make up with full Render finish and traditional flat roof. The font elevation contains a number of powder coated grey aluminum window and door frames along with larger glazed windows to the ground floor commercial unit.

The Installation of the freestanding guard rail edge protection consists of galvanised steel tube rails (approx. 45mm Diameter) standing 1100mm from the roof finish level at maximum 3m centers. The system is counter weighted with freestanding rubber pads sat upon the roof.

The property is proactively and reactively visited by contractors whom require access to the roof in order to carry out maintenance, inspections and repairs. In order to ensure compliance with falling from height regulations and provide safe access and egress onto the roof area, the freestanding edge protection was the chosen system for installation. The system was chosen due to its ability to be installed freestanding without puncturing the roof surface or injuring the fabric of the building, while also It's practicality and accessibility in providing a cost effective solution to the risk of falls enabling many different types of contractors to safely work upon the roof area without the need for specialist equipment. The system also reflects a similar design and appearance of edge protection systems installed on neighboring properties.

There are many similar and larger developments within the near vicinity of the subject property whom have installed similar guard rail systems. Most notably and immediately adjacent both the UCU University College Union and apartment buildings within the Three Fields Estate contain similar systems installed along their roof lines.

Due to the edge protection chosen being freestanding in nature, the need to seek planning consent was overlooked in error and the system already installed. After communication with Camden Council Planning Department and as required, consent is now being sought for this installation.
