Tree type - Lime (Tillia sp.)
Approx. Diameter at 1.5m - 0.5-1m
Approx Height - 13m
Approx Spread - 6m

Location - Front garden, Front boundary

Service - pollard

Work required- Reduce height by removing around 5m to establish a new pollard at around 8m (to match pollarded height of plane tree adjacent at number 20). Remove remaining growth back to previous points and remove epicormic growth from main stem and around base. Reason - As part of regular cyclical maintenance, to reduce encroachment over adjacent road and footpath. To form a more compact, manageable crown.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
