REAR GARDEN: 1 x Sorbus (T1) - Crown reduce height by 2m - 3m. Reduce laterals by 0.5m - 1m. Thin 10%.

1 x Fig (T2) - Crown reduce height and sides 3m - 4m. Thin 10%. Lift 4m.

The Council has considered your notification of intended works to trees dated 24 January 2024 and does not wish to object.
