T1- Sycamore tree-(16m) trunk pushing and damaging wall- crown reduction back to approximately 2m bellow previous pruning points.

The proposed work is to reduce the tree to 2m bellow the most recent pruning points. The proposed work is to slow the growth of the tree and reduce the future damage to the wall adjacent to the pavement.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
