The retroactive Listed Building Consent for the restoration of the roof at 4 Sandwich Street, London, WC1H 9PL. The works included the replacement of the roof covering of the building down to the existing roof boarding, with new counter battens, breather felt, treated softwood battens, and natural slates. A small black rooflight was also introduced to replace an existing lead roof hatch. The rear flat roof was re-covered with like for like materials that comprised of a high performance built-up roof felting system with PIR insulation and incorporated vapour barrier.
