Full Planning Permission Granted

Address: 16 Flat 2nd Floor Glenmore Road London Camden NW3 4DB

Proposal: Installation of 2 new rooflights in the rear roof slope;

Drawing Nos: 2304-10, 2304-11, 2304-12, 2304-13, 2304-14, Design & Access Statement 2304/100.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 The development hereby permitted shall be carried out in accordance with the

following approved plans: 2304-10, 2304-11, 2304-12, 2304-13, 2304-14, Design & Access Statement 2304/100.

Reason: For the avoidance of doubt and in the interest of proper planning.

3 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 of the London Borough of Camden Local Plan 2017.

Informative(s):

1 Reasons for granting permission:

Two rooflights are proposed to be installed, one within the pitch roof of the main house and one within the flat roof of the two storey rear closet wing. The rooflights are of an appropriate size and would be set below an existing rooflight. The rooflights design, size, scale and material would all be acceptable and in accordance with the character and appearance of the existing building and the surrounding conservation area.

Given the siting of the rooflights high on the sloped roof and on the flat roof of the closet wing, it is not considered the rooflights would seen from the public realm; and therefore, would not result in any significant loss of residential amenity to the neighbouring properties from loss of light, overlooking or overbearing impacts.

No comments were received following statutory consultation. The sites planning history and relevant appeal decisions were taken into account when coming to this decision.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

As such, the proposed development is in general accordance with policies A1 (Managing the impact of development), D1 (Design) and D2 (Heritage) of the Camden Local Plan 2017. The proposal accords with the London Plan 2021 and the NPPF 2023.

2 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. You are advised to consult the Council's Building Control Service, Camden Town Hall, Judd St, Kings Cross, London NW1 2QS (tel: 020-7974 6941).

- 3 This approval does not authorise the use of the public highway. Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2023.
