The principle of the conversion of the office space to a non-retail art gallery is supported.

In terms of design, the proposals are generally supported and the approach taken to minimise changes to the historic building fabric, in particular at the external elevations, is welcomed.

The main change proposed is the construction of an entry porch and stair. Given that this would largely be hidden from view, subject to its final high quality design, the scheme has the potential to preserve both the character and appearance of the conservation area and the setting of listed buildings.

The proposed works would likely be considered acceptable in terms of amenity effects.
