Were hoping to get a 5 day notice on this to complete works this year before it knocks the wall down and also causes any damage to Rosslyn hill Chapel or drops a branch on the public there,

T1 - Refers to Large Beech Tree spread of 16M height of around 18meters, looking to reduce crown by around 2.5 meters this will be thinned in removing slightly more than meters but will allow us to achieve target pruning and a nice natural reduction, crown will be thinned by a reasonable 40%

Works are to maintain the beautiful tree and pro longs it life within the urban environment and considered reasonable management for this tree, allowing more light into all gardens and reduce further damage to the wall to the side of the tree,

- if there are many trees on the site, make clear which tree(s) are included in this application by:

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
