Rear garden

T1 apple x 1 To shape and contain. Suggested works- Reduce all round to previous reduction points approx. 1m leaving shortened furnishing growth

Rear garden

T2 Ash x 1 (Fraxinus excelsior) This previous pollarded tree has several cavities at crown break. To lessen weight and improve light to garden.

Suggested works- Reduce to previous reduction points approx. 2-3m leaving shortened furnishing growth

Front between Chalcot gardens and England lane

T3 Lime x 1 (Tilia spp) This previously pollarded tree has not maintain for some time and has recently shed a large branch.

To maintain. Suggested works- Reduce all round to previous reduction points by approx. 6-7m in height and approx. 2m laterally

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:

 - $\circ~$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
