Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 Poplar of the MWA Arboricultural Report

Works: Remove (fell) to near ground level and treat stump to inhibit regrowth.

Reason: Structurally the tree is compromised and suffering from significant main stem decay with a visible open decaying wound to the main stem from approx. 2.0m to approx. 4.5m above ground level on the north-eastern aspect of the main stem. In terms of the risk of direct damage and possible injury from whole or part tree failure this is currently assessed as high.

NOTE: Tree appears older than property – possible heave risk in the event of removal. In the even that the council consent to the removal of this tree, the owner will carry out a heave assessment prior to any works taking place.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).
