T1: Mature Walnut: Approximately 11.00m: Reduce crown by approximately 1.20m-1.50m by means of reducing overlong branches which extend out of the main crown structure. Thin crown density throughout by approximately 20%. Remove major dead wood throughout. General maintenance.

T2 & T3: 2 x Olive trees: Approximately 6.00m: Reduce crowns of both trees by approximately 1.00m. Thin crown density's by 20%-25%.
