T1 Lime x 1 (Tilia spp) This multi stemmed tree is in a poor condition with some large dead wood and cavities at crown break of main
stem. Suggested works- Remove dead wood - Reduce main stem to the pollard points approx. 8m
- Reduce younger stems to the approx. height of the pollard points on older stem approx. 5m

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- Reduce back to boundary with pavement
