The proposed chain link fence will be 50mm x 50mm x 3.5mm galvanised and powder-coated black and positioned above the brick boundary wall. It will be supported using 900mm x 50mm metal saddles chemically bolted to the wall and bolted to 50mm x 10mm metal flat bars with 25mm diameter rod support, similar to the existing design. All metal is to be painted black with a smooth matt finish.
